Sealed tender under single bid System affixing court fee stamp (IPO in case of Tenderers outside Assam) worth Rs. 8.25 (Rupees eight & twenty five paisa) only are invited from registered Advertising Agencies for hiring of Hoardings on monthly basis for Assam State AIDS Control Society. The validity of the tender is 3 (Three) months.

1. ELIGIBILITY CRITERIA

- a. Bidder should be a registered Govt. approved Advertising Agency.
- b. The firm should have a minimum turnover of Rs.20,00,000/- p.a.
- c. Supply shall be affected directly by the bidder and not through any other agency.

2. GENERAL CONDITIONS

- a) A complete set of bidding documents may be purchased by any interested eligible bidder on submission of written application and upon payment of the cost of tender document (non – refundable) of Rs.300/- in the form of Demand Draft/ Banker’s Cheque in favour of PD, Assam State AIDS Control Society payable at Guwahati. The Bidding document may be obtained during office hours on all working days. The tender documents may also be downloaded from the official website- www.assamsacs.org.The bidder downloading the Bid document from the website will be required to deposit Rs.300/-(non – refundable) in the form of Demand Draft drawn in favour of “ Assam State AIDS Control Society” payable at Guwahati while submitting the Tender.
- b) All bids must be accompanied by **EARNEST MONEY DEPOSIT** amounting to Rs. 4,000/- in the form of Demand Draft/ Banker’s Cheque in favour of the Project Director, Assam State AIDS Control Society, payable at Guwahati.
EMD of the successful bidder shall be retained till completion of the contract but shall not carry any interest. In case the successful bidder fails to execute the agreement or withdraws his bid within the validity period of the bid, the EMD shall be forfeited. The EMD of the unsuccessful bidders will be returned within 30 days from the date of finalization of the tender.
- c) Bids shall be opened in presence of bidders/ representatives who intend to attend, on the specified date and time.
- d) At any time prior to the date of submission of bid, the authority inviting tender may, for any reason, whether at his own initiatives or in response to a clarification from a prospective bidder, modify the bidding documents by an amendment. All prospective bidders who have received the bidding document will be notified of the amendment in writing and the amendment shall be binding on them. In order to provide reasonable time

to take the amendment into account in preparing the bid, the authority inviting tender, may at his discretion, extend the date and time for submission of bids.

- e) The bid and all correspondence and documents shall be in the English language.
- f) The tender document is not transferable.
- g) The Bidding Document shall be signed by the tenderer in all the pages with official seal.

Quotation without original Bidding Document shall be rejected.

- h) Interested eligible bidders, if so desire, may obtain further information from the office of the authority inviting tender.

3. ELIGIBILITY CRITERIA

The bidder shall furnish the following documents to establish his eligibility.

- a) Copy of Memorandum of Article/ Partnership Deed/ Affidavit for Sole Proprietorship (whichever is applicable)
- b) Copy of Service Tax Registration Certificate and Current Return.
- c) Copy of up to date valid Trade License.
- d) Copy of PAN Card.
- e) Order copies received from different organizations during last three consecutive preceding years as per the format specified at **Annexure-I**.
- f) Annual Turn Over Statement along with Income Tax Return Acknowledgement for last 3 years in the specified format (Refer **Annexure II**) certified by the Auditor/ Chartered Accountant.
- g) Undertaking in the form at **Annexure III** confirming acceptance of all terms and conditions of the tender.
- h) An undertaking on fraud and corruption as per **Annexure IV**.
- i) Sample of flex (A4 size- 1no.) needs to submit along with the tender duly signed by the bidder under institutional seal. Installation will be executed as per the sample.
- j) The bidder should be an advertising agency with its own space. Supporting documents should be enclosed.

4. BID PRICE

- a) Bidder should submit Price-Bid as per Format specified in **Annexure- VI**. Corrections, if any, should be done by crossing out, initializing, dating and rewriting.
- b) The Bid Price shall be the landed cost at destination, inclusive of packing, forwarding, Excise Duty, Sales Tax/VAT, Freight, Insurance, Installation, rent, maintenance etc, if any.
- c) Each page of the price bid shall be duly signed by the bidder with official seal.
- d) List of locations for rented hoarding is available at **Annexure-VI**.

5. SPECIFICATIONS AND QUANTITY

- a) **Name of item:** Rented Hoarding
- b) **Quantity:** 20 nos. (Quantity may be increased or decreased).
- c) **Period:** 2 (Two) years. (May be extended further with mutual consent)
- d) **Size of Hoarding:** 20 ft. X 12 ft and 30 ft X 15 ft.

- f) **EMD amount:** Rs.4,000/-.
- g) **Printing of Flex:** Hi-shine flex of 340 GSM thicknesses with digital multi-colour printing of the message.
- h) The contents of the message for the hoarding shall be provided by ASACS to the selected bidder (s).
- i) The messages will be printed in multicolor and in Assamese, English, Bengali and Hindi.
- j) In case, any defect is noticed/ reported from districts or Inspection Team of ASACS, the same will be rectified immediately without additional cost.
- k) The selected bidder shall ensure display of the advertisement and maintain it for a period of one month from the date of its display. In case of any damage, torn out for any reason, the hoardings will be repaired/ replaced by the firm immediately at their cost within a period of 3 days.
- l) The firm will pay taxes, if any for installation of the hoardings.

6. BID EVALUATION

The bidder to quote the lowest rate (L1) may not be the successful bidder if he fails to fulfill the technical/ specifications criteria. **Bidder(s) to fulfill all technical/ specifications criteria shall only be recommended for Price Bid Evaluation.** Conditional discounts shall not be taken into account for price comparison. However, same shall be considered in case of placing order if the bidder happens to be L1.

7. VALIDITY OF TENDER

Bids shall remain valid for a period of 3 (Three) months from the date of submission of tender. Purchaser may solicit bidders' consent to an extension of bid Validity period

8. VALIDITY OF RATE

The rate will be valid for 2 (Two) years from the date of finalization of the tender. The validity of rates may further be extended with mutual consent. However, the Tendering Authority reserves the right to reduce/ cancel the validity period.

8. STATUTORY TAXES/ DUTIES

In case of any enhancement of Taxes and/ or duties or levy of fresh Taxes/ duties due to Statutory Act of the Govt., after date of submission of the tenders and during the contractual

delivery period, additional or fresh levies so imposed will be allowed to be claimed as extra without any change in the price structure approved under the tender. For this purpose, the supplier shall produce a certificate from the authority concerned certifying that the item supplied falls under particular tariff resulting in additional/ fresh levies for the supplied item. However, the same shall not be borne by the purchaser in case such levies become applicable after expiry of the contractual delivery period stipulated in the contract.

9. AGREEMENT

The successful bidder shall execute an agreement as per proforma in **Annexure VII** within 7 days from the date of the intimation from Tender Inviting Authority informing that his tender has been accepted.

10. ANNULMENT OF AWARD, FORFEITURE OF SECURITY DEPOSIT & FRESH AWARD

Failure of the successful bidder to comply with the requirements of signing of contract and / or submission of performance security within the time schedule as stipulated above shall constitute sufficient grounds for annulment of the award and forfeiture of the bid security.

Under such a situation, the proposal may be reviewed for award of the contract on the next lowest evaluated technically qualified bidder or go for a fresh bid depending on the circumstance.

11. INSPECTION & QUALITY ASSURANCE

The purchaser and /or his authorized representative(s) have the right to inspect the facilities of the Units to quote for this tender, before accepting their rates or before awarding the contract, or at any point of time during the continuance of the tender and has also the right to reject the tender or not to reorder based on facts brought out during such inspections.

However, such inspection shall not absolve the supplier from his responsibility of strictly adhering to the specifications & other conditions spelt out in the tender.

12. DELIVERY CONDITION

- i) The contract should be executed within 7 days from the date of receipt of the Order.
- ii) The units as per order shall be handed over to the authorized representative(s) of the purchaser at the specified location and the same shall be duly receipted.
- iii) On specific request made by the bidder the time period of supply may be extended by the purchaser at his discretion for such period as may be considered reasonable.
- iv) Submission of samples of Flex is a must.

13. PENALTY FOR DELAY IN DISPLAY

- a) In case there is delay in display of Hoardings beyond the stipulated period as mentioned in delivery clause, there shall be reduction in price @ 0.5% of the value of delayed goods per week of delay or part thereof subject to a maximum of 10% of the total order value.
- b) Once the maximum price reduction is reached, termination of the contract may be considered.
- c) Non-performance of the contract provisions shall make the successful bidder liable to be disqualified to participate in any tender for the next 5 years, in addition to forfeiture of EMD and Performance Security and other penal provisions.

21. FORCE MAJUERE

The above condition of delivery period, price reduction & termination etc. are subject to force majeure conditions which are beyond the control of the supplier, do not involve fault or negligence of the supplier and are not anticipated. Such events may include but are not limited to riots, mutinies, war, fire, storm, tempest, flood, epidemics, or other exceptional causes like quarantine restrictions, freight embargoes. However, the condition shall not include scarcity of raw materials, power cut, labour dispute, failure of sub-vendor and increase in cost of raw material.

22. FRAUD & CORRUPTION:

The bidders, suppliers & contractors shall observe the highest standard of ethics during bidding and during performance of the contract. For the purposes of this provision, the following acts shall be considered as corrupt and / or fraudulent practices -

- a) "Corrupt Practice" means offering, giving, receiving, or soliciting directly or indirectly, of any thing of value to influence the action of an official in the procurement process or in contract execution.
- b) "Fraudulent Practice" means misrepresentation or omission of facts in order to execution of contract.
- c) "Collusive practice" means a scheme or arrangement between two or more bidders, with or without the knowledge of the purchaser, designed to establish bid prices at artificial, non-competitive level.
- d) "Coercive Practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in a procurement process or in execution of a contract.

During the process of evaluation of a bid or proposal for award of a contract, if it is detected that a bidder directly or through agent has engaged in corrupt, fraudulent, collusive or coercive practice in competing for the contract in question, then a) the bid shall be rejected

and b) declare the firm ineligible for a specific period or indefinitely to participate in a bidding process.

In the bid document itself, an undertaking from the bidders may be obtained in the format at **ANNEXURE- III.**

23. LOCAL CONDITIONS

It will be imperative on each bidder to fully acquaint himself of all local conditions and factors that would have any effect on performance of the Contract. The purchaser shall not entertain any request for clarifications from the bidder regarding such local conditions nor shall accept any offer conditional to the local factors. No request for any change of price or extension of time schedule of delivery of goods shall be entertained after purchaser accepts the bid.

24. WAIVAL/ ALTERATION ETC

Bidders request for waive, alteration etc. in respect of bid document fee, EMD, performance security etc. shall not be entertained and hence no formal reply shall be given for such requests.

The bids shall not be opened of those bidders who have not complied with the provisions of the Bid Document Fee and / or EMD clause of the Tender Document.

25. SAVING CLAUSE

No suit, prosecution or any legal proceedings shall lie against Tender Inviting Authority or any person for anything that is done in good faith or intended to be done in pursuance of tender.

26. LAWS GOVERNING THE CONTRACT & JURISDICTION

The contract shall be governed by the laws in force in India. In the event of any dispute arising out of the tender such dispute would be subject to the contract shall be governed by the laws in force in India. In the event of any dispute arising out of the tender such dispute would be subject to the jurisdiction of the Civil Court within the city of Guwahati only.

27. PAYMENT TERMS :

The paying authority on production of the following documents shall make payment:-

- a. Invoice in triplicate accompanied with 2 nos. of photographs of each of the Hoardings - One from front and the other from back side duly sealed and signed by the party concerned.

- b. On receiving of above documents the paying authority will conduct inspection to the installation sites through its officials and after getting positive verification report payment will be released.

3. In consideration of the payments to be made by the Purchaser to the Bidder as hereinafter mentioned, the Bidder hereby covenants with the Purchaser to print and install the hoardings and to remedy defects therein in conformity in all respects with the provisions of the Contract.
